
3 Investment Options

By check: Make check payable to The RBB Fund Trust.

Note: All checks must be in U.S. Dollars drawn on a domestic bank. The Fund will not accept payment in cash or money orders. The Fund does not accept post-dated checks or any conditional order or payment. 4 Cost Basis Method


