

# Penn Capital Defensive Short Duration High Income Fund

## Overview

The Penn Capital Defensive Short Duration High Income Fund ("Fund") seeks to provide a high level of current income. The Fund seeks to achieve its investment objective by investing, under normal circumstances, primarily in short-term fixed income securities and senior floating rate loans that are rated below investment grade.

## Investment Philosophy

- Focuses on Single-B and above credit quality high yield debt
- Seeks to capitalize on short duration paper likely to be re-financed/retired
- Seeks to include corporate fixed-rate bonds and floating-rate bank loans
- Seeks to fill void created by total-return funds selling their lowest yielding securities

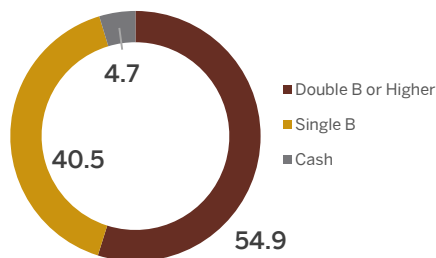

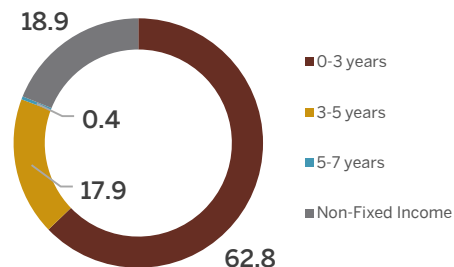

## Description of Indices and Terms

**Average Maturity:** For a single bond, it is a measure of maturity that takes into account the possibility that a bond might be called back to the issuer. For a portfolio of bonds, average effective maturity is the weighted average of the maturities of the underlying bonds. The measure is computed by weighing each bond's maturity by its market value with respect to the portfolio and the likelihood of any of the bonds being called.

The BofA ML 1-3 Yr. BB US Cash Pay High Yield Index is a subset of The Bank of America Merrill Lynch US Cash Pay High Yield Index including all securities with a remaining term to final maturity less than 3 years and rated BB1 through BB3, inclusive. An investor cannot directly invest in an index.

The BofA ML US HY Cash Pay BB-B Rated 1-3 Year Index is a subset of The Bank of America Merrill Lynch US Cash Pay High Yield Index, which tracks the performance of non-investment-grade corporate bonds with a remaining term to final maturity less than three years and rated BB-B. An investor cannot directly invest in an index.

The BofA Merrill Lynch 1-3 Year BBB US Corporate Index is subset of the BofA Merrill Lynch US Corporate Master Index tracking the performance of US dollar denominated investment grade rated corporate debt publicly issued in the US domestic market. This subset includes all securities with a remaining term to maturity of less than 3 years. An investor cannot directly invest in an index.

## Fund Risks

The Fund is subject to the following risks, among others: ETF risk, which is the risk that the fund is subject to the same risks as the underlying securities in which the ETF invests as well as entails higher expenses than if invested into the underlying ETF directly; foreign securities and ADRs, which involve certain risks such as currency volatility, political and social instability and reduced market liquidity.
